IN 2012 OUR OUTREACH PROGRAM INCLUDED THE PUBLICATION OF A BOOK OF ESSAYS AND ARTWORK BY LOCAL ARTISTS AND WRITERS THAT SHOWCASED THE MANY BENEFITS OF LAND CONSERVATION. THE CONSERVANCY ALSO CONTINUED TO HOST THE WILD AND SCENIC FILM FESTIVAL IN SUMMIT COUNTY. ADDITIONALLY, CONSERVANCY STAFF CONTINUED TO ATTEND LOCAL AGENCY MEETINGS TO INFORM OFFICIALS OF THE WORK WE DO.
