THE CONSERVANCY CONTINUED TO BRING THE WILD AND SCENIC FILM FESTIVAL TO PARK CITY AND INCLUDED TWO SCREENINGS OF THE FILMS. THE CONSERVANCY DEDICATED MORE RESOURCES TO PARTICPATING IN STAKEHOLDER GROUPS IN NORTHERN UTAH IN 2013, INCLUDING WEBER RIVER PARTNERSHIP, MOUNTAIN ACCORD, PARK CITY AND SUMMIT COUNTY OPEN SPACE COMMITTEES, SUMMIT COUNTY'S AGRICULTURAL COMMITTEE AND FRIENDS OF THE FARM.
